Eastern Region*-- North Carolina 2003 Youth Tobacco Survey (YTS)

HIGH SCHOOL FACT SHEET



The North Carolina YTS includes data on the prevalence of cigarette and other tobacco products as well as information on tobacco use, environmental tobacco smoke (ETS), cessation, pro-health media, tobacco advertising, school tobacco prevention education, community participation, and access and availability of tobacco products. These areas are critical components that North Carolina should include in a comprehensive tobacco control program.

The North Carolina YTS was a public school-based survey of students in grades 6-12, conducted in 1999, 2001 and 2003¹. A multi-stage cluster sample design was used to produce representative data for middle and high school students for all of North Carolina. Schools were selected with the probability proportional to enrollment size. Classes were randomly selected and all students in selected classes were eligible to participate. The 2003 YTS eastern region school response rate was 97.1%, the student response rate was 82.7% and the overall response rate was 80.3%. A total of 1115 eastern region high school students participated in the North Carolina YTS in 2003.

Prevalence

68.6% of students had ever used any tobacco product (Male = 68.5%, Female = 68.5%)²

63.6% of students had ever smoked cigarettes (White = 62.1%, Black = 64.4%, Hispanic = 73.2%)

 $34.0\% \ of \ students \ currently \ use \ any \ to bacco \ product \ (Male=37.6\%, \ Female=30.5\%)$

28.0% currently smoke cigarettes (White = 31.6%, Black = 22.5%, Hispanic = 36.5%)

5.2% currently use smokeless tobacco (Male = 9.1%, Female = 1.4%)

Environmental Tobacco Smoke (ETS)

46.32% live in homes where others smoke

28.37% are in the same room as others who smoke during the week

69.16% think smoke from others is harmful to them

Cessation – Current Smokers

48.7% want to quit smoking

58.7% attempted to quit smoking in the past year

Pro-health Media vs Tobacco Advertising

89.3% saw or heard anti-smoking media messages in the past month

23.12% have an object with a tobacco brand logo

School

25.45% were taught the dangers of tobacco in the past year 12.0% smoked on school property in the past month

Community

12.2% participated in a community event to discourage tobacco use

Access and Availability- Current Smokers < 18 years old

11.8% buy cigarettes in stores

59.7% who bought cigarettes in a store were NOT refused purchase because of their age

High School Highlights

Nearly 7 in 10 students have used tobacco; 34% currently use some form of tobacco; 28% currently smoke cigarettes; 5% currently use smokeless tobacco (spit, chew or dip)

ETS exposure – nearly 3 in 10 students were in the same room with smokers during the week

Nearly 7 in 10 students think smoke from others is harmful to them

Almost half of current smokers want to quit smoking

Almost 9 in 10 students saw or heard anti-smoking media messages in the past month

More than 2 in 10 were taught the dangers of tobacco in past year

1 in 10 smoked on school property

1 in 10 participated in a community event to discourage tobacco use in the past year

6 in 10 currently smoking students were not refused the purchase of cigarettes due to their age
